


**Office on Violence Against Women  
Discretionary Grants  
Grants to Reduce Violent Crimes Against Women on Campus Program  
Report Period: January 1—June 30, 2006**

The primary purpose of the Campus Program is to develop and strengthen victim services in cases involving violent crimes against women on campuses. The Campus Program also aims to strengthen security and investigate strategies to prevent and prosecute violent crimes against women on campuses.

**Victim Services:** Campus Program grantees provided services to more than **1,300** victims of sexual assault, domestic violence and stalking.

Total number of grantees using funds for victim services: **48** (75% of all grantees)

**Victim services and demographics:** Campus Program grantees provided an array of services to victims/survivors of sexual assault, domestic violence and stalking, including victim advocacy (actions designed to help victims/survivors obtain needed resources or services), crisis intervention, and legal advocacy (assistance navigating the criminal and/or legal system). Victims/survivors receive referrals and information as needed.

**Number of victims receiving the following services:**

- Victim advocacy: **1,005** (76% of those receiving services)
- Crisis intervention: **712** (54%)
- Hotline calls: **634** (48%)
- Support group/counseling services: **396** (30%)
- Legal advocacy: **226** (17%)
- Hospital response: **102** (8%)
- Disciplinary board advocacy: **98** (7%)
- Housing assistance: **88** (7%)
- Civil legal assistance: **1** (<1%)



Percentages are based on the total number of known relationships in each victimization category.

**Training:** Campus Program grantees train professionals to improve the response to victims/survivors of sexual assault, domestic violence and stalking and to increase offender accountability.

Total number of grantees using funds for training: **56** (88% of all grantees)

Total number of people trained with Campus funds: **7,926**

Number of training events: **480**

**Education for incoming students:** All Campus grantees must implement and operate educational programs for the prevention of violent crimes against women as part of an overall coordinated campus and community response to violence against women on campuses.

**Staff:** Campus Program staff provides training, prevention education, and victim services to ensure a coordinated response to violence against women on campus.

**Campus and community measures:** Campus Program grantees are required to collect and report on all sexual assault, domestic violence and stalking offenses that either occurred on campus or that occurred off campus and involved students.

### Campus and Community Measures

**110** offenses resulted in criminal charges being filed in the local jurisdiction  
**130** offenses resulted in campus disciplinary/judicial board actions

**189** victims reported crimes occurring on campus  
176 of these reported to campus police/security  
13 reported to community law enforcement

**191** victims reported crimes occurring off campus  
162 of these reported to community law enforcement  
29 reported to campus police/security

**79** temporary protection orders were requested and **77** were granted (97%)  
**74** final protection orders were requested and **64** were granted (86%)
