

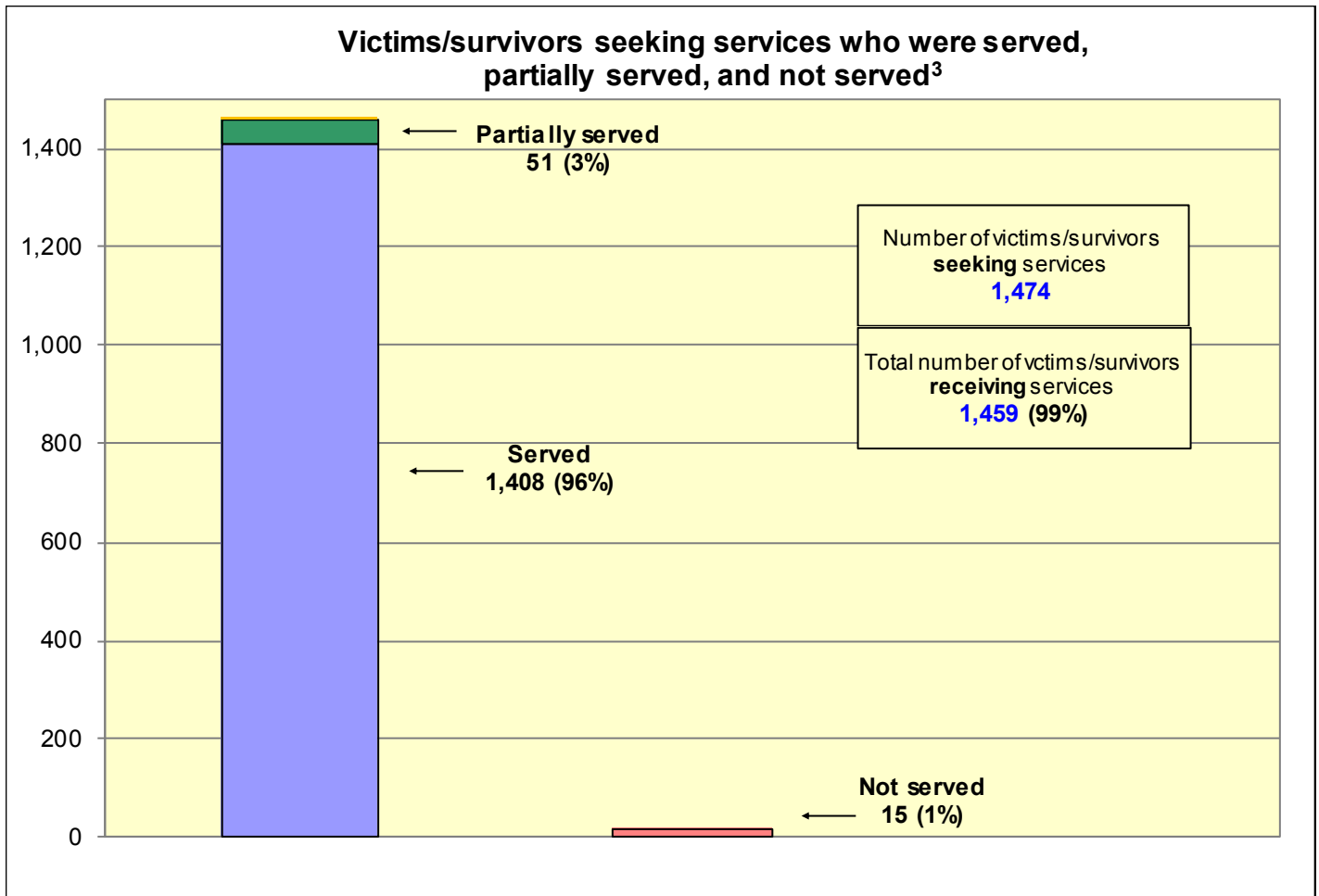

**Sexual Assault Services Culturally
 Specific Grant Program
 (SASP Culturally Specific
 Grant Program)^{1,2}**

The purpose of the SASP Culturally Specific Grant Program is to create, maintain, and expand sustainable sexual assault services provided by culturally specific organizations, which are uniquely situated to respond to the needs of sexual assault victims within culturally specific populations.

Victim Services: SASP Culturally Specific Grant Program grantees provided services to **1,459** victims/survivors of sexual assault to help them become and remain safe from violence.

Victim services and demographics: SASP Culturally Specific Grant Program grantees provide an array of services to victims/survivors of sexual assault including victim advocacy (actions designed to help the victim/survivor obtain needed resources or services), counseling/support group, crisis intervention, and legal advocacy (assistance navigating the criminal and/or legal system). Victims/survivors receive safety planning, referrals, and information as needed.

Number of victims/survivors receiving the following services:

- Counseling services/support group: **1,078** (74% of those receiving services)
- Crisis intervention: **565** (39%)
- Victim/survivor advocacy: **471** (32%)
- Material assistance: **239** (16%)
- Transportation: **221** (15%)
- Civil legal advocacy/court accompaniment: **208** (14%)
- Language services: **156** (11%)
- Hospital/clinic/other medical response: **91** (6%)
- Employment counseling: **84** (6%)
- Job training: **58** (4%)
- Criminal justice advocacy/court accompaniment: **53** (4%)
- Financial counseling: **50** (3%)

- U visa: **37** (3%)
- VAWA self-petition: **10** (1%)
- Other immigration matters:⁴ **7** (<1%)

Staff: SASP Culturally Specific Grant Program staff provide victim services and outreach to increase victim/survivor safety.

Number of grantees using funds for staff: **28** (100% of all grantees reporting)
