

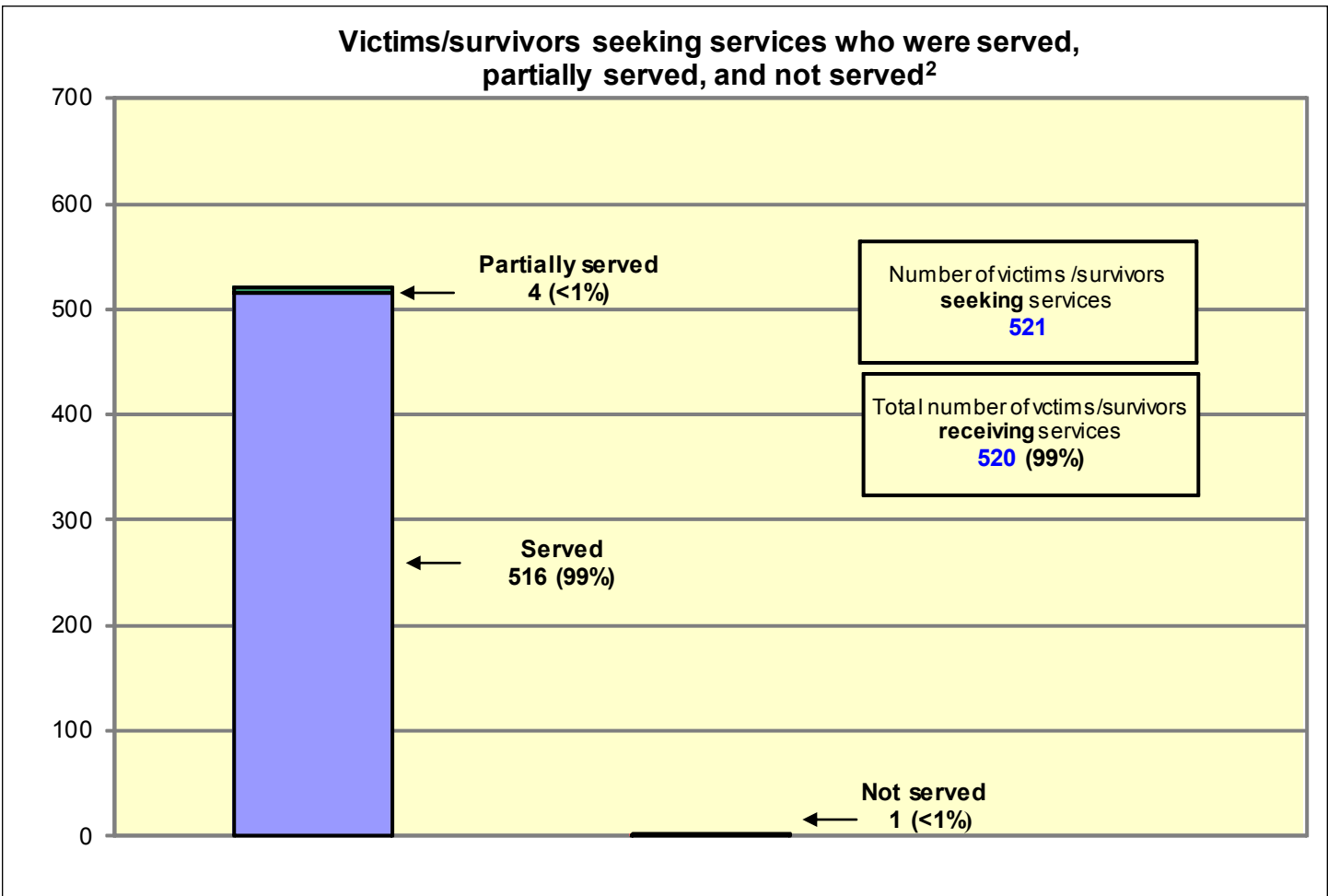


**Sexual Assault Services Program Grants
 to Culturally Specific Programs Violence
 Against Women Grant Program
 (SASP Culturally Specific
 Grant Program)¹**

The purpose of the SASP Culturally Specific Grant Program is to create, maintain, and expand sustainable sexual assault services provided by culturally specific organizations, which are uniquely situated to respond to the needs of sexual assault victims within culturally specific populations.

Victim Services: SASP Culturally Specific Grant Program grantees provided services to **520** victims/survivors of sexual assault to help them become and remain safe from violence.

Victim services and demographics: SASP Culturally Specific Grant Program grantees provide an array of services to victims/survivors of sexual assault including victim advocacy (actions designed to help the victim/survivor obtain needed resources or services), counseling/support group, crisis intervention, and legal advocacy (assistance navigating the criminal and/or legal system). Victims/survivors receive safety planning, referrals, and information as needed.

Number of victims/survivors receiving the following services:

- Crisis intervention: **316** (61% of those receiving services)
- Counseling/support group: **289** (56%)
- Victim/survivor advocacy: **181** (35%)
- Transportation: **111** (21%)
- Material assistance: **105** (20%)
- Language services: **79** (15%)
- Financial counseling: **57** (11%)
- Employment counseling: **48** (9%)
- Hospital/clinic/other medical response: **41** (8%)
- Criminal justice advocacy/court accompaniment: **34** (7%)
- Civil legal advocacy/court accompaniment: **33** (6%)
- Job training: **25** (5%)

Number of victims/survivors receiving assistance with Immigration matters:

- U visa: **27** (5% of those receiving services)
- Work authorization: **15** (3%)
- VAWA self-petition: **2** (<1%)
- Other immigration matters:³ **2** (<1%)

Number of hotline calls and requests for information and referral received from victims/survivors:

- Hotline calls: **394**
- Web-based requests: **157**
- Walk-in requests: **49**

Number of outreach activities to victims/survivors: **629**

- ♦ Other family member: **127** (28%)

Staff: SASP Culturally Specific Grant Program staff provide victim services and outreach to increase victim/survivor safety.

Number of grantees using funds for staff: **16** (89% of all grantees reporting)

Total number of full time equivalent staff funded⁷	22
Victim advocate (45% of all staff funded)	10
Program coordinator (27%)	6
Counselor (18%)	4
Administrator (9%)	2
