

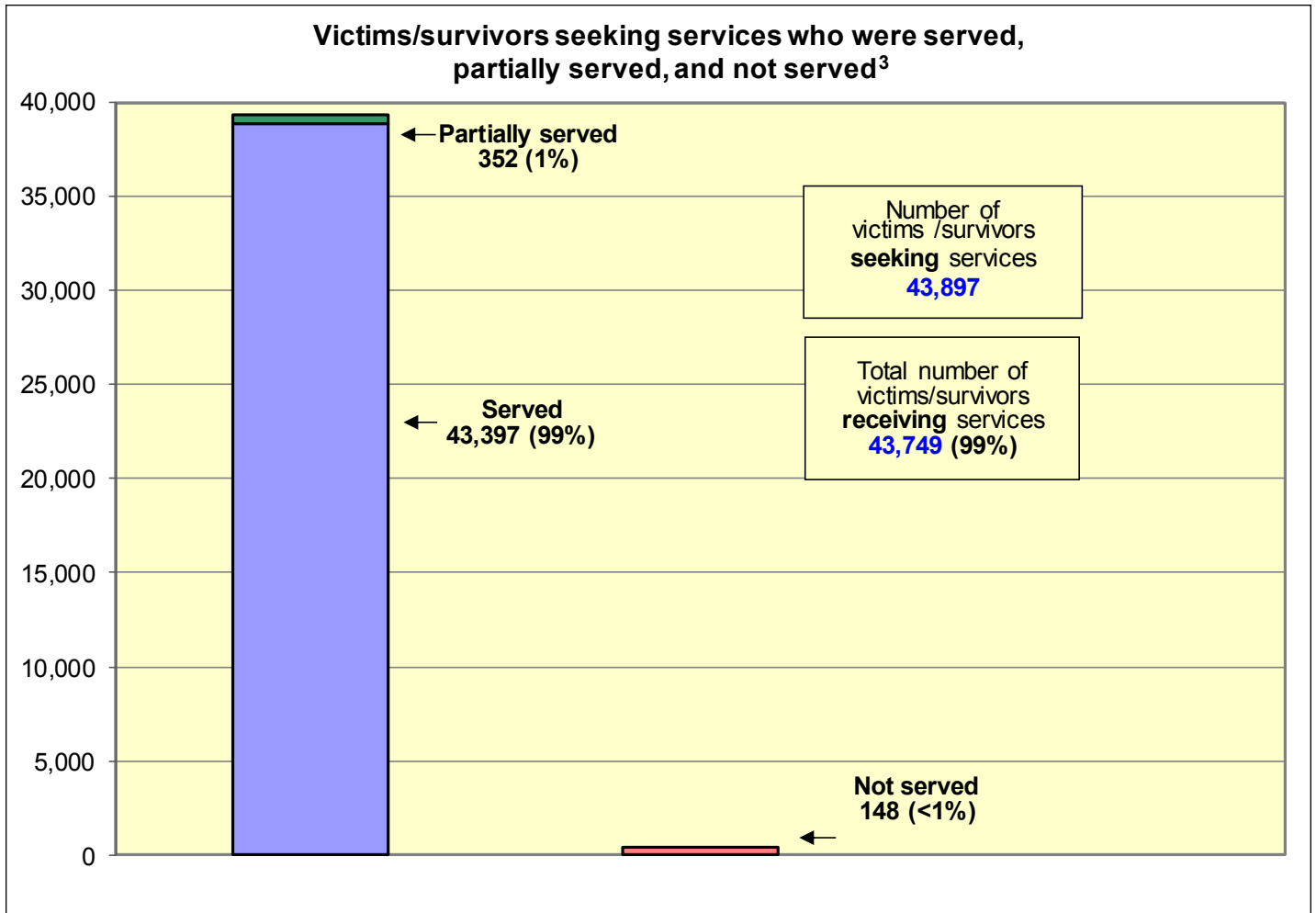

**Sexual Assault Services Formula
 Grant Program
 (SASP Formula)**
Subgrantee Annual Data Report¹

The purpose of the SASP Formula Grant Program is to provide intervention, advocacy, accompaniment, support services, and related assistance for adult, youth, and child victims of sexual assault, family and household members of victims, and those collaterally affected by the sexual assault. This program supports efforts to help survivors heal from sexual assault trauma through direct intervention and related assistance from social service organizations such as rape crisis centers through 24-hour sexual assault hotlines, crisis intervention, and medical and criminal justice accompaniment.

Victim Services: SASP Formula subgrantees provided services to **43,749** victims/survivors of sexual assault to help them become and remain safe from violence.

Victim services and demographics: SASP Formula subgrantees provided an array of services to victims/survivors of sexual assault including victim advocacy (actions designed to help the victim/survivor obtain needed resources or services), counseling/support group, crisis intervention, and legal advocacy (assistance navigating the criminal and/or legal system). Victims/survivors receive safety planning, referrals, and information as needed.

Staff: SASP Formula-funded staff provide victim services and outreach to increase victim/survivor safety.
