

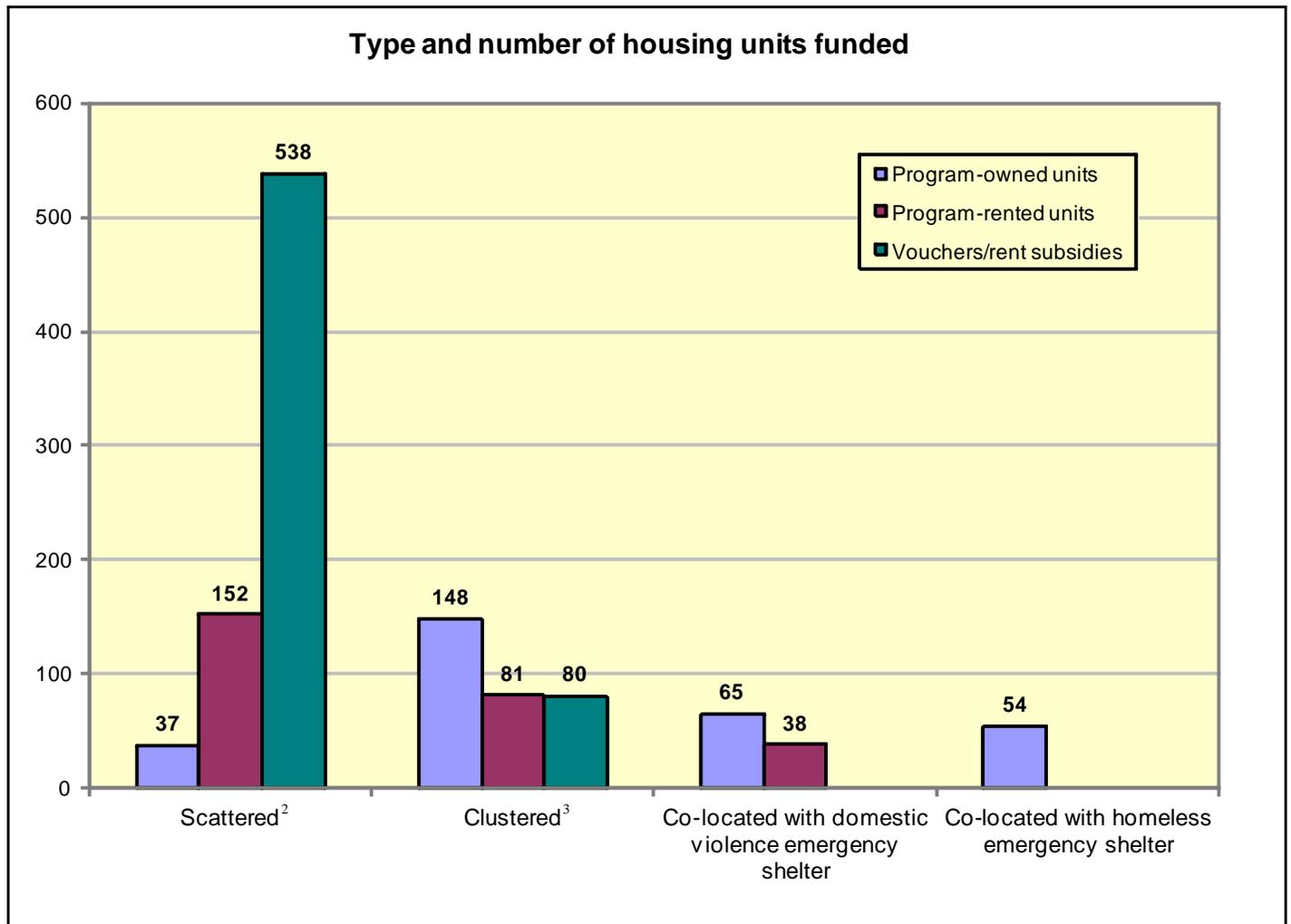


The purpose of the Transitional Housing Program is to support programs that provide assistance to individuals who are homeless or in need of transitional housing or other housing assistance as a result of fleeing a situation of sexual assault, domestic violence, dating violence, and stalking, and for whom emergency shelter services or other crisis intervention services are unavailable or insufficient.

Program Description: Transitional Housing Program grantees provide housing units, which include program-owned units, program-rented units, and units paid for with voucher or rental assistance.

Number of grantees using funds for housing units: **131** (67% of all grantees reporting)



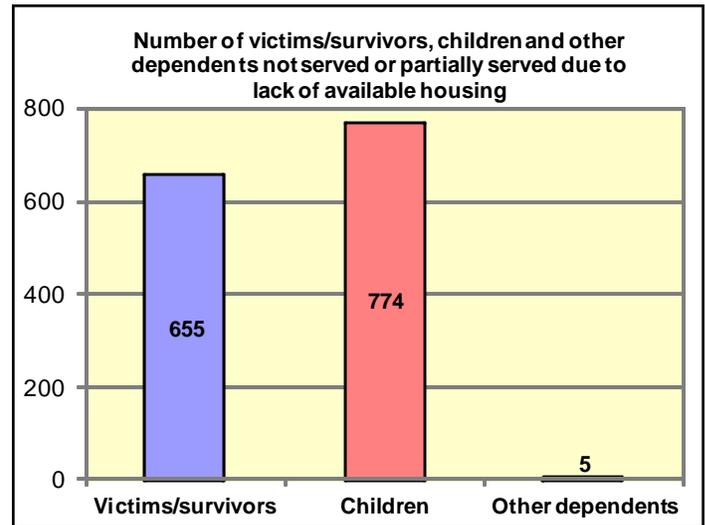
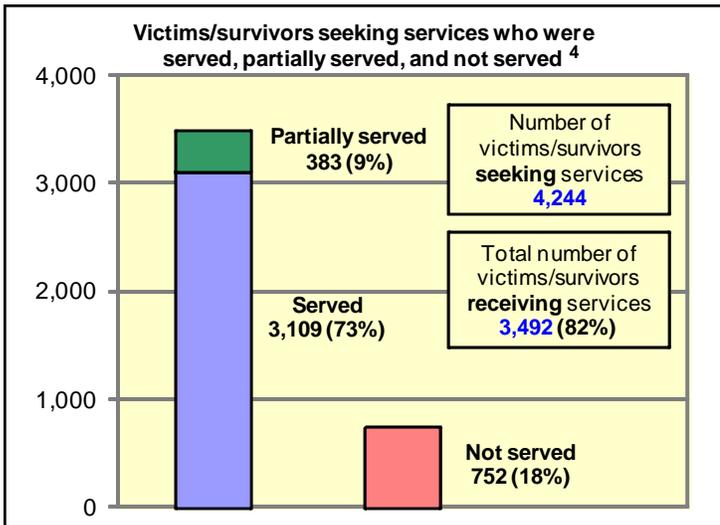

Victim Services: Transitional Housing Program grantees provided services to nearly **3,500** victims/survivors of sexual assault, domestic violence, dating violence, and stalking and nearly **4,700** children and **59** other dependents to help them become and remain safe from violence.

Number of grantees using funds for victim services: **169** (86% of all grantees reporting)



Victim Services and Demographics: Transitional Housing Program grantees provided an array of support services designed to enable victims/survivors, who are fleeing sexual assault, domestic violence, dating violence, or stalking, to locate and secure permanent housing and integrate into a community by providing those individuals with services such as: transportation, counseling, child care services, case management, employment counseling, and other assistance. Victims/survivors receive safety planning, referrals, and information as needed.

- Counseling/support group: **1,953** (56%)
- Housing advocacy: **1,786** (51%)
- Material assistance: **1,638** (47%)
- Other advocacy: **1,611** (46%)

- Financial counseling: **1,437** (41%)
- Transportation: **1,086** (31%)
- Employment counseling: **1,060** (30%)
- Civil legal advocacy/court accompaniment: **463** (13%)

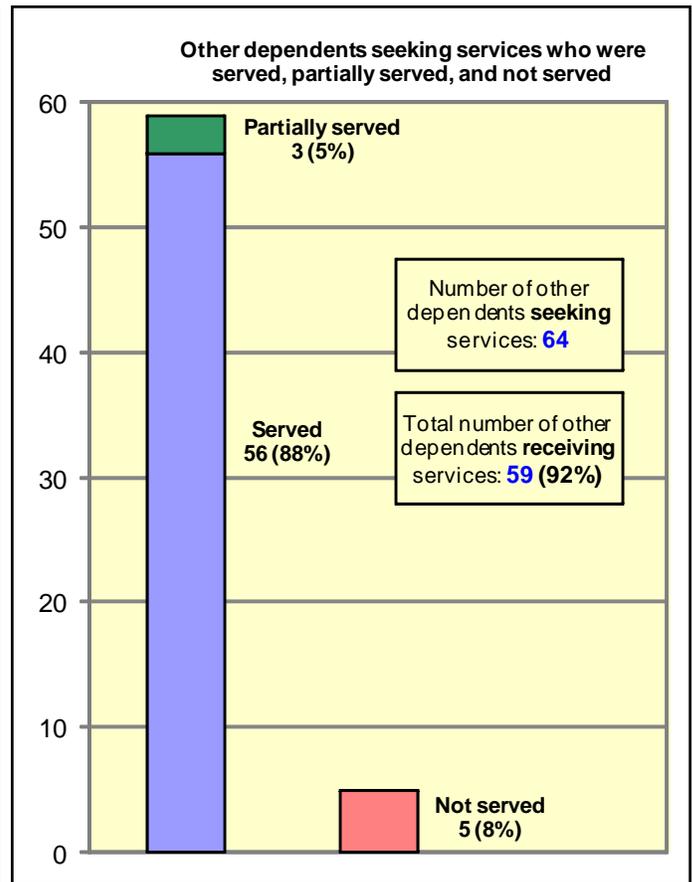
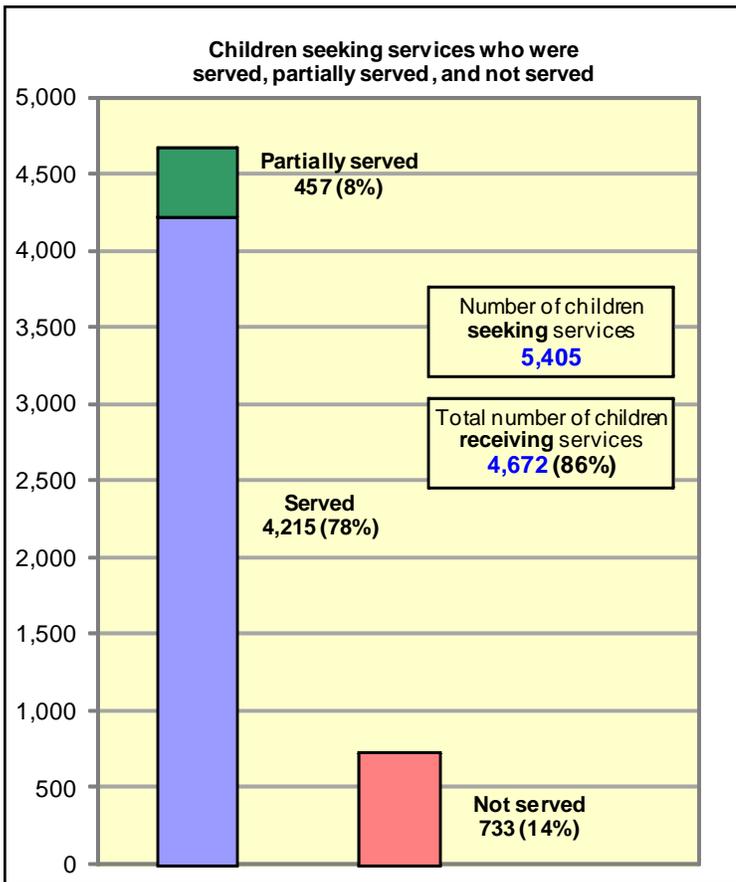

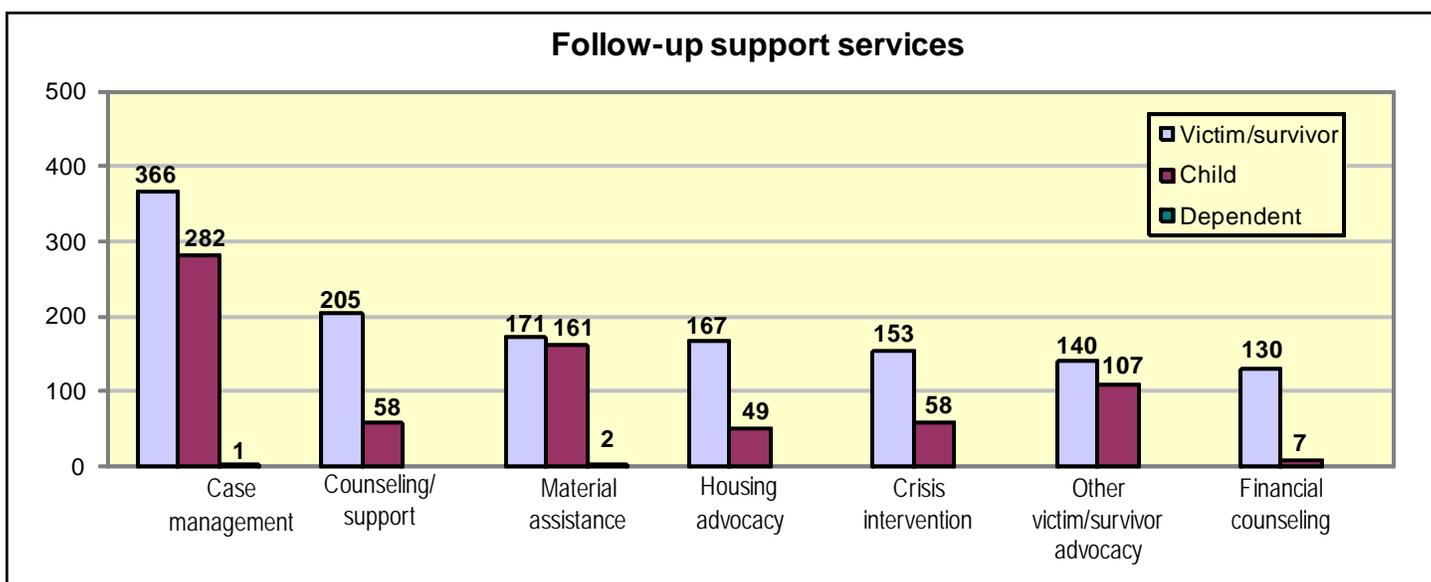

Staff: Transitional Housing Program staff provide victim services, including advocacy, counseling, financial assistance, material assistance, transportation, and child care services to increase victim and child safety.
